#### **RESOLUTION**

A RESOLUTION OF THE UNIVERSITY OF WEST FLORIDA BOARD OF TRUSTEES APPROVING THE DESIGN, CONSTRUCTION, EQUIPPING AND FINANCING OF STUDENT HOUSING FACILITIES TO BE LOCATED ON THE CAMPUS OF THE UNIVERSITY OF WEST FLORIDA; AUTHORIZING THE UNIVERSITY OF WEST FLORIDA FOUNDATION, INC. TO REQUEST THE ISSUANCE OF REVENUE BONDS; AUTHORIZING THE DEVELOPMENT OF AN APPROPRIATE SUBLEASE; AUTHORIZING STAFF TO REQUEST NECESSARY APPROVALS FROM THE **BOARD** OF **GOVERNORS**: **AUTHORIZING** THE PRESIDENT AND STAFF TO TAKE FURTHER ACTIONS CONSISTENT WITH THIS **RESOLUTION**; AND PROVIDING AN EFFECTIVE DATE

The undersigned, being the duly acting and appointed University of West Florida Board of Trustees (the "Board") at a meeting duly held pursuant to notice and a quorum being present, do hereby make the following resolutions:

#### **BE IT RESOLVED:**

#### Section 1. Findings.

The Board hereby finds as follows:

- (a) The Board is responsible for the governance of the University of West Florida (the "University"), a constituent institution of the State University System of Florida.
- (b) Pursuant to the provisions of Sections 1004.28 and 1010.62, Florida Statutes, the University or its direct support organization may issue or cause the issuance of obligations to finance, design and construct facilities necessary and desirable to serve the needs and purposes of the University in accordance with the University's master plan.
- (c) Pursuant to the provisions of Section 1013.171, Florida Statutes, the University is authorized to enter into agreements to lease land under its jurisdiction to a direct support organization to be used to construct thereon facilities necessary and desirable to serve the needs and purposes of the University as determined by the University's master plan.
  - (d) The University of West Florida Foundation, Inc., a Florida not-for-profit

corporation (the "Foundation") was created for the purpose of providing direct support to the University of West Florida (the "University"), and has been designated as a "University Direct Support Organization" as defined in Section 1004.28, Florida Statutes, and continues to be so designated.

- (e) The Foundation has participated in providing financing for the University's student housing facilities, including the issuance of the outstanding Dormitory Revenue Bonds, Series 1998 (University of West Florida Foundation, Inc. Project) (the "1998 Bonds") issued by the Escambia County Housing Finance Authority (the "Authority"), the Dormitory Revenue Bonds, Series 2005 (University of West Florida Foundation, Inc. Project) (the "2005 Bonds") issued by the Authority, and the \$15,000,000 Dormitory Revenue Bond (University of West Florida Foundation, Inc. Project), Series 2009 (the "2009 Bond") issued by the Authority (the 1998 Bonds, the 2005 Bonds, and the 2009 Bond as described herein being herein collectively referred to as the "Outstanding Bonds"), the proceeds of which were used to finance the construction of certain student housing facilities at the University on land leased to the Foundation by the University.; and
- (f) The University desires to acquire additional housing facilities and is in the process of requesting market studies and financial analysis concerning the most advantageous structure and amenities and has asked the Foundation to indicate its willingness to participate in providing financing for such additional student housing facilities (the "2010 Project") by requesting the issuance of revenue bonds to finance a portion of the cost of such student housing facilities, in the estimated amount of not in excess of \$17,000,000, including estimated costs of issuance and interest during construction (the "2010 Bonds").
- (g) The construction of additional student housing facilities on the campus of the University is contemplated in the University's master plan and therefore complies with the overall strategic plan of the State University System.

## Section 2. Approval of Construction and Acquisition of Additional Student Housing Facilities.

The Board hereby approves the construction and acquisition of additional student housing facilities in the amounts not exceeding the amounts set forth in Section 1 hereof. Staff of the University is authorized and directed to examine the market studies, financial analyses, and competitive proposals and to proceed to develop the most advantageous structure and amenities. The University will work with the board and staff of the Foundation to insure that projected proceeds from housing system operations remain sufficient to meet all requirements of the Outstanding Bonds and/or additional debt undertaken at the University's request.

# Section 3. Authorization of Necessary Amendments to Sublease Agreement and Assignment Thereof.

The existing student housing system for the University is located on land leased to the

Foundation pursuant to the terms of the existing Sublease Agreement between the Board and the Foundation dated September 1, 1998, as amended by that certain First Amendment to Sublease Agreement dated October 1, 1999, as further amended by a Second Amendment to Sublease Agreement dated August 1, 2002, as further amended by a Third Amendment to Sublease Agreement dated April 1, 2009 (collectively, the "Sublease Agreement"). Amendments to such Sublease Agreement as may be necessary to accomplish the financing herein described in form approved by the President of the University are hereby approved by the Board.

### Section 4. Approval of 2010 Bonds.

The Board hereby approves issuance by the Foundation of the 2010 Bonds in an amount not to exceed \$17,000,000, with the final terms of the 2010 Bonds to be established by the Foundation and approved by the Board prior to issuance thereof for the purposes designated elsewhere in this Resolution, and further reaffirms its approval of the existence and purposes of the Foundation. This approval is subject to the understanding that the 2010 Bonds do not create any obligation of the Board, the State of Florida, or any political subdivision, department, or agency thereof, to pay any part of the principal or premium, if any, or interest on the 2010 Bonds, or to levy ad valorem taxation or any other form of taxation to repay the same, but rather such 2010 Bonds shall be solely the non-recourse obligation of the Foundation, to be repayable solely from revenues of the student housing system.

#### Section 5. Authorization of Further Actions Consistent Herewith.

The President of the University, attorneys, engineers or other agents or employees of the University and the Board are hereby authorized and directed to do all acts and things required of them by this resolution, or desirable or consistent with the requirements thereof, for the full, punctual, and complete performance of all the terms, covenants and agreements contained in the Sublease Agreement, and this Resolution, including execution of such documents, certificates, contracts, and legal opinions, and other material delivered in connection with the sale of the 2010 Bonds.

### Section 6. Board of Governors Approval.

The President and staff of the University are authorized and directed to work with the Board of Governors and the State Division of Bond Finance to provide appropriate information in order to obtain any necessary approvals.

#### Section 7. Repealing Clause.

All resolutions of the Board, or parts thereof, in conflict with the provisions herein contained, to the extent they conflict herewith, are, to the extent of such conflict, hereby superseded and repealed.
