

## University of West Florida Cooperative Education Syllabus/SLOs – Summer 2009

Cooperative Education (CoOp) allows students to gain professionally relevant work experiences that complement their academic studies. It is a partnership among employers, students, and the university focused on professional practice and vocational exploration. Combining paid work experience with their studies CoOp students have an opportunity to explore their professions and apply principles acquired in the classroom.

**All assignments must be completed and submitted to the CoOp Office in order to receive a passing grade for CoOp credit hours.**

**Students enrolled in CoOp credit hours will receive 100 points each semester. You are encouraged to complete and turn in your assignments on time.**

**Written permission of your CoOp Advisor is required to adjust published deadlines. Points will be deducted as follows if assignments are received after the published deadlines.**

## University of West Florida Cooperative Education Student Learning Outcomes

### Communication Skills

1. The student will be able to demonstrate the ability to follow written materials.
2. The student will be able to communicate ideas and concepts clearly in writing.
3. The student will have the ability to listen to others in an active and attentive manner.
4. The student will be able to effectively articulate in meetings or group settings.
5. The student will be able to demonstrate effective verbal communication skills by being able to ask pertinent and purposeful questions.

### Vocational/Career Preparation

1. The student will be able to break down complex tasks/problems into manageable pieces.
2. The student will be able to formulate options and ideas.
3. The student will be able to demonstrate ability to problem solve.
4. The student will be able to demonstrate a self-motivated approach to work.
5. The student will demonstrate an ability to set appropriate priorities/goals.
6. The student will be able to demonstrate professional behavior and attitude.
7. The student will report to work as scheduled and on-time.
8. The student will demonstrate skills for appropriate dress and appearance for a professional organization.

### Leadership

1. The student will be able to manage and resolve conflicts in an effective manner.
2. The student will show the ability to support/contribute to a team atmosphere.
3. The student will be able to demonstrate assertive, but appropriate behavior.
4. The student will exhibit the ability to understand/support the cooperative employer's organizational mission/goals.
5. The student will demonstrate behavior that fits in with the norms and expectations of the organization.
6. The student will be able to seek out and utilize appropriate resources.
7. The student will be able to work within appropriate authority and decision-making channels.

### Integrity/Values

1. The student will be able to exhibit a positive and constructive attitude.
2. The student will be able to demonstrate a sense of values and integrity to the job.
3. The student will be capable of learning from previous mistakes.
4. The student will be able to behave in an ethical manner.
5. The student will be able to show respect for the diversity (religious/cultural/ethnic) of co-workers.

Learning outcomes will be measured by cooperative education employer's evaluation, student report, student reflection and assistant director of cooperative education evaluation. Student's ability to meet these outcomes is expected to improve with the completion of each cooperative education experience semester. Each experience will be different as they are dependent upon the student's major and the cooperative employment experience.
