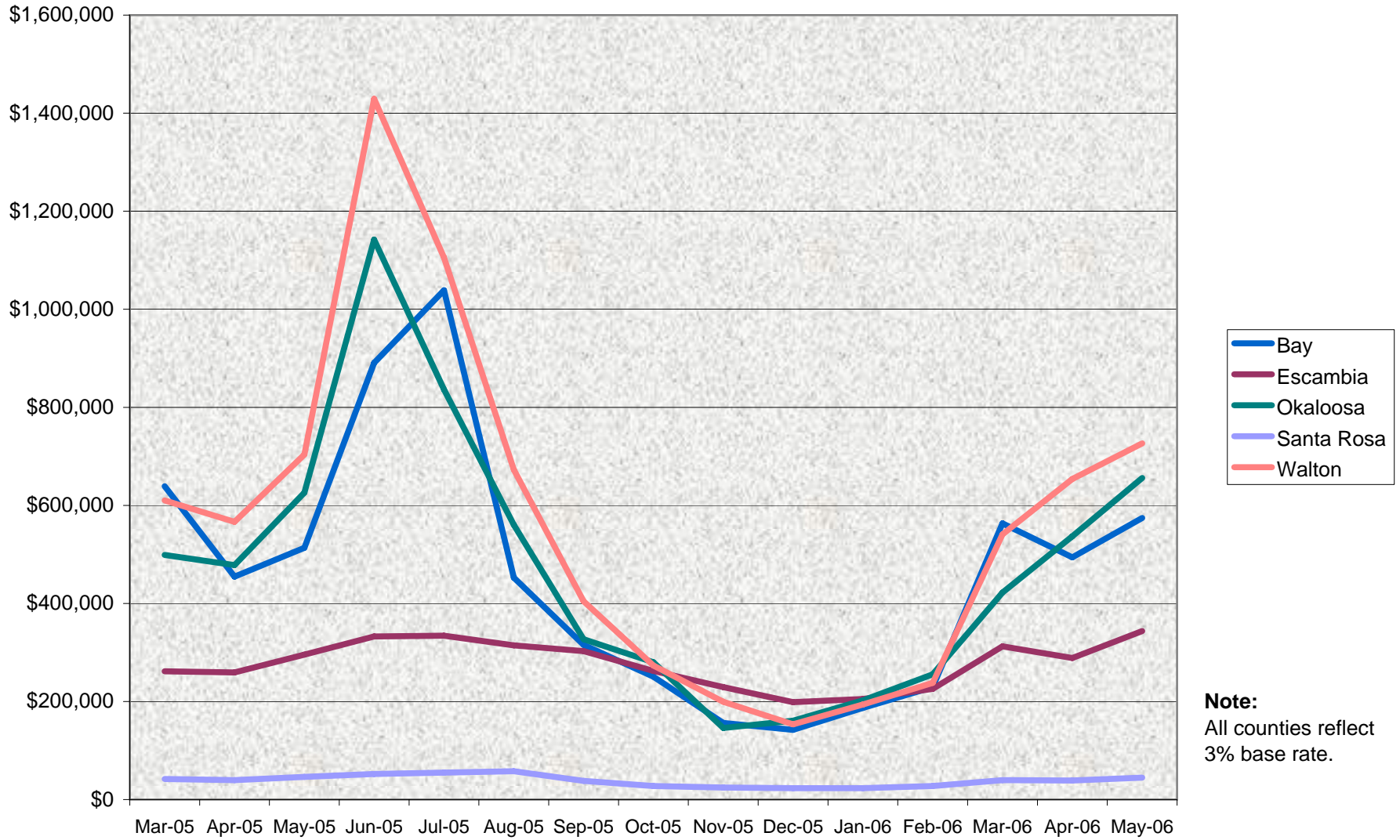

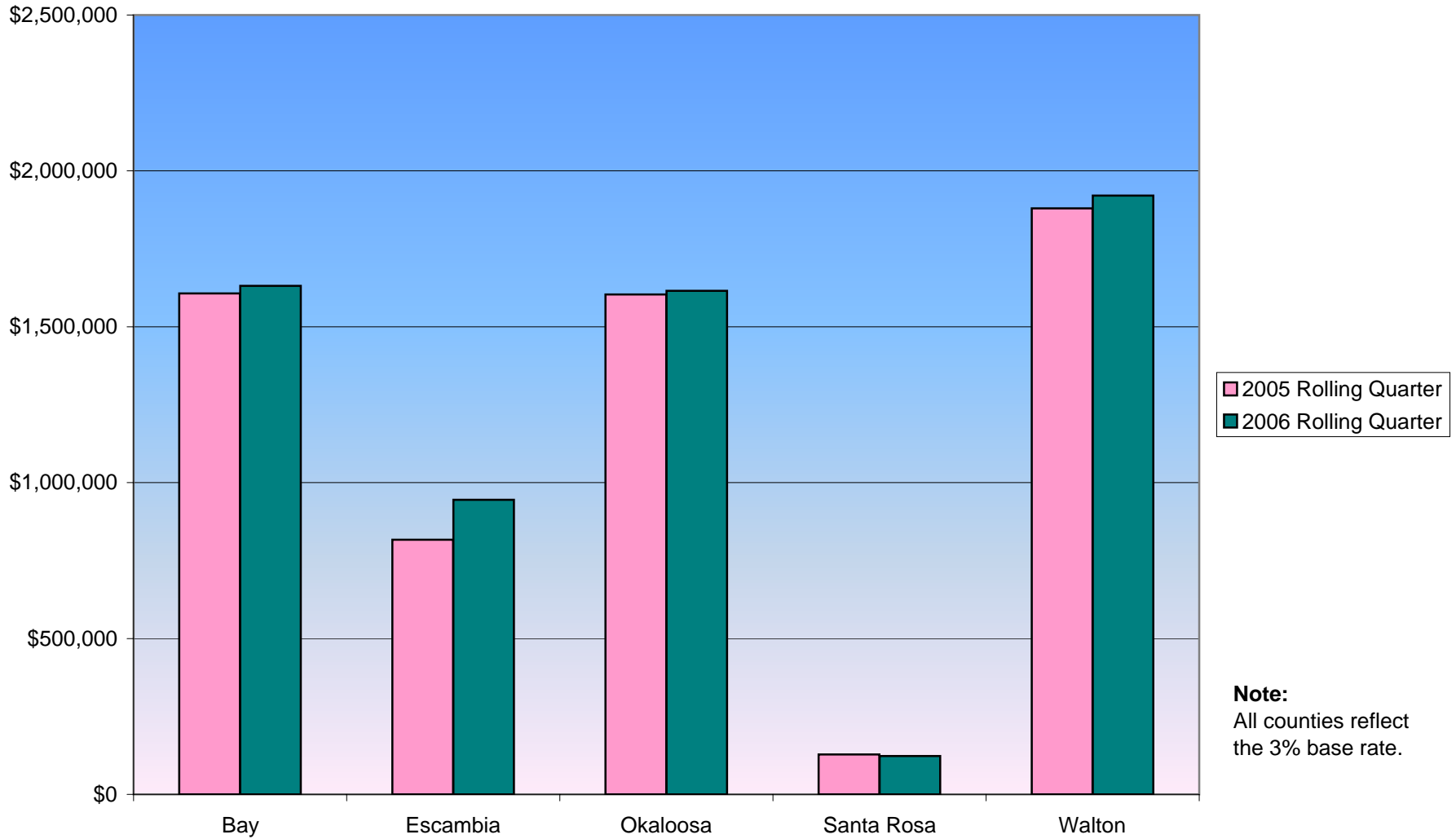
After consultation with Bay County Clerk of Court regarding Bay County's bed tax collections, the Haas Center revised the data series beginning August 2005 until the present.
