REGULATION TITLE: **UWF/REG 4.008 - Tuition and Fees, Fines and Penalties (Fall 2006)**

PURPOSE AND EFFECT: The purpose and effect of the proposed regulation is to reflect the amount of tuition, fees, fines and penalties at the University.

SUMMARY: Establishes tuition rates, fees, fines and penalties as approved by the University of West Florida Board of Trustees.
