### **Committee Roles**

Those present asked Chair Jipson and Kyle Marrero to write a letter to President Bense on behalf of the HARC that reemphasizes the terms and importance of an impartial and fair nomination process. These procedures must be followed when accepting all nominations, including those from Board of Trustee members, Foundation Board members, or other community members. The HARC committee members want to ensure the nomination, awards and recognition processes remain at the highest level of integrity.

# **HONORARY DEGREE CANDIDATE**

There was consensus among committee members to approve the nomination of Mr. Jerry Maygarden to receive the LHD: Doctor of Humane Letters Honorary Degree and to invite Mr. Maygarden to be the December 2013 commencement speaker.
