## **The Excellence in Women's Studies Award**

### **Criteria and Guidelines**

The Excellence in Women's Studies Award recognizes UWF faculty for substantial scholarship in the field of women's studies and/or making a positive difference in the lives of women in the Northwest Florida community. Each award recipient receives a \$500 (gross) cash award and a plaque. Award will be presented at the annual luncheon during the Women's Studies Student Conference. The award recipient will be honored as the keynote speaker at the conference.

### **Eligibility**

Full-time and part-time University faculty members are eligible to apply or be nominated for the award.

Honorees will be selected on the basis of outstanding scholarship as well as service to the university and the community, as documented by the nomination form and supporting materials.

Previous awardees are not eligible for three years.

Honorees should plan to be available on March 27, 2009 to deliver the keynote address at the student conference luncheon. If the honoree is unable to attend the conference, arrangements will be made to find another speaker in his or her place.

Nominations received after 1:00 p.m. on the deadline date of Friday, February 27, 2009 will be declared ineligible.

### **Application/Nomination Process**

Nominations may be by self-nomination or nomination by others (peers, supervisors, colleagues from other divisions, etc.), must be on the official nomination form and must include two (2) letters of recommendation.

Nominators are responsible for obtaining the two letters of recommendation.

The two letters of recommendation must mention the nominee's outstanding performance and significant impact on women's studies and/or community.

Questions on the nomination form must be answered in detail.

Nominations must be received by the deadline of 1:00 p.m. Friday, February 27, 2009.

### **Selection Process**

The award recipient will be selected based on criteria stated above.

A committee composed of at least three (3) members of the Women's Studies advisory board will choose the recipient.

Selection Committee members may not submit nomination(s).

The honoree will be announced on March 2, 2009
