    - ii. Debate: Chair Costa: She is the most passionate
      - 1. Senator Hicks, Point of Inquiry: Why wasn't this made public for those who might have been interested in it
        - a. President Marshall: Kayla graduated, and Chief of Staff Harris and Kayla made a recommendation for Lauren, and that is why we offered her the position, this is the quickest way to get everybody in
      - 2. Vice Chair Montoya: When President Marshall and Vice President Proffitt, whenever Senator Strickland came up, and I feel like when it comes to diversity, military, and mental health, her ideas of diversity don't really fit with what SGA is offering, and I think there is someone else who would be a better fit

    - iii. Questions:
      - 1. Chair Costa; What plans do you have for this semester?
        - a. Stikclaln: I plan on a diversity panel, Dr. Harnette, STEM panels women in stem, panels have faculty and community members so that we can honor you

- 2. Senator Hicks: You didn't answer chair costa's questions do you have any other ideas for diversity week, what are you going to do?
  - a. Senator Strickland: The panel is something that I and Kayla set up, me and Kayla had no help
  - b. Senator Hicks: What are you planning?
  - c. Senator Strickland: We had a fashion show planned, and now we have time to plan events
- 3. Senator Pogreba: I am on the Diversity Committee, are we actually going to have meetings, we only had a few meetings we are busy, but there's no communication to help or propose ideas
  - a. Senator Strickland: I apologize for any miscommunication, and I will have mandatory meetings, that was the prior leadership
- 4. Senate Pro Tempore Range: What do you define as diversity?
  - i. Senator Strickland: I am 36, my dad was a drug addict, I grew up in a bad place, and I have been researching DEI, I have a passion for food insecurity, and I am looking forward to sharing my passion with you guys
- 5. Vice Chair Montoya: What does your research show?
  - i. Senator Strickland: It showed that people like me that didn't fit traditionally, people that couldn't stand up for themselves, and that people of color and people like me are being disregarded in higher education. What is happening in law, we are not fitting in. We need to make sure that everyone is accepted, and research shows that it will get better but only if we are putting in the work, this is a big deal for me, this is the only place that I have felt accepted, and here I am trying to be better, I also would like to help MGC orgs, where is diversity at, stats are not near POC or older people

#### iv. <u>Debate:</u>

- a. Senator Hicks: She didn't answer the questions we asked, and she was upset at me for answering them, and she got angry, and communication in a positive manner is one of the most important things as a diversity leader-she didn't give good answers about diversity and initiatives
- b. Vice Chair Montoya: As a POC, it is hard to be in the norm, I know that you can know that, but we had project grants, and we need to find a solution not address the problem, those examples don't hit LGBTQ, and POC, and she does not fit the mission that we are going for
- c. Senator Nelson: I didn't have much doubt about Senator Strickland, but raised the concern, is that Senator Pogreba, at the actual organization, and how timely they are about

- meetings, another side of the issue that needs to be addressed, leadership faulty, didn't feel the most comforting, so if Senator Pogreba should shed some light and be more assured
- d. Senator Pogreba: I have a lot of respect for Senator Strickland, I want someone who is a minority and from my background, because I'm gay and I wish there was more than that, I want to look up to someone who isn't an everyday person, I wish we could have opened this up to everyone so that this wouldn't be happening
