We get our funding through the green fee for the edible trees and bushes planted around campus and a digital map showing all the edible plants on campus. In the past couple of years, I have taken on multiple roles. My newest role is the Director of Conservation. In the past, UWF wanted to develop the acres of land around the campus. Fortunately, they never did, and now these forest areas are protected and meant to be preserved so students can enjoy them.
