

EXTENSION & AMENDMENT

THIS EXTENSION #_____AND AMENDMENT OF THE AGREEMENT (the “Extension”), is made and entered into on the last date signed below, by and between **THE UNIVERSITY OF WEST FLORIDA BOARD OF TRUSTEES (“UWF”)**, and _____, (“Contractor”).

WHEREAS, UWF and Contractor entered into that certain agreement dated _____, as it may have been renewed and/or amended (collectively, the “Agreement”); and

WHEREAS, the parties desire to extend the Agreement, and make other modifications as set forth herein.

WHEREAS, Florida Board of Governors Regulation 18.001(1)(h) provides that UWF may permit the extension(s) of a contract, entered into as a result of a competitive solicitation, for up to twelve (12) months or until completion of the competitive solicitation and award or protest, whichever is longer.

NOW THEREFORE, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 12. No counterparts; Signatures.** This Extension may not be executed in counterparts. This Extension may be signed electronically and such electronic signatures shall constitute an original for all purposes. The parties represent and warrant that any person signing the Extension electronically has the authority to do so and that such electronic signature shall be sufficient to bind Contractor. This Extension shall be considered signed if/when a party's signature is delivered by facsimile or e-mail transmission of a ".pdf" format date file, including via DocuSign. Such signature via DocuSign shall be treated in all respects as having the same force and effect as an original signature.
- 13. E-Verify.** The Contractor and its subcontractors have an obligation to utilize the U.S. Department of Homeland Security's (DHS) E-Verify system for all newly hired employees in accordance with section 448.095, F.S. By executing this Agreement, the Contractor certifies that it is registered with, and uses, the E-Verify system for all newly hired employees in accordance with section 448.095, F.S. The Contractor must obtain an affidavit from its subcontractors in accordance with paragraph (2)(b) of section 448.095, F.S., and maintain a copy of such affidavit for the duration of the Agreement. The Contractor shall provide a copy of its DHS Memorandum of Understanding (MOU) to the UWF within five (5) days of Agreement execution. This section serves as notice to the Contractor regarding the requirements of section 448.095, F.S., specifically subparagraph (2)(c)1, and the UWF's obligation to terminate the Agreement if it has a good faith belief that the Contractor has knowingly violated section 448.09(1), F.S. If terminated for such reason, the Contractor will not be eligible for award of a public contract for at least one (1) year after the date of such termination. The UWF will promptly notify the Contractor and order the immediate termination of the contract between the Contractor and a subcontractor performing work on its behalf for this Agreement should the University have a good faith belief that the subcontractor has knowingly violated section 448.09(1), F.S.
