Administrative Reports

1. Executive Report – Dr. Jaromy Kuhl – University Provost.

a. Staff Senate President, Ethan Henley, asked if Dr. Kuhl could address last week and this week with Dr. Saunders announcement. Dr. Saunders is still our President; will not change until the Board of Trustees decides on a timeline; now waiting on them to make those decisions. Senator At Large, Sierra Ebert, asked about the process for selecting a new President. Provost Kuhl shared one of the main functions of the Board of Trustees is selecting a President. There will be a search and people will apply. Jamie Sprague (HR) also shared there is a Florida Statute (1004.098) and Board of Governors Regulation (1.002) that governs how Presidential selections has to happen. General Counsel and Jamie Sprague will be working with the Board of Trustees. Right now, Presidential selection does not have to be part of the sunshine until they are ready to bring a finalist to campus. There is no minimum number of finalists that can be presented for a final interview. The Board of Trustees could also name an Interim President in the meantime.

2. Human Resources - Jamie Sprague
